Chris started his legal practice, and still concentrates a significant portion of his time, in the area of contract negotiations and drafting and all forms of dispute litigation and arbitration related to the construction industry. He has experience representing numerous contractors, private owners and developers, state and local public entities, bonding companies, design professionals, and subcontractors/suppliers. His representation includes drafting and negotiating all forms of commercial construction-related contracts. He has participated in the drafting and negotiation of general contracts for numerous large commercial projects that exceeded \$30 million in value. His experience includes both contract drafting and negotiation and litigation of disputes involving the construction of hotels, municipal arenas, hospitals and medical facilities, multifamily housing projects, and large office buildings. He also has extensive experience representing clients in asserting and defending against mechanic's liens and payment and performance bond claims. Past cases include successfully representing a regional general contractor in an arbitration recovery against the owner of a large office building and recovering the full amount of the claim, including interest and attorneys' fees. He also successfully defended a large general contractor in arbitration against claims by the owner of an apartment complex for delays and defective construction.
